The Akash Education society, 405, Ocean Complex, Sector - 18, Noida (G.B. Nagar) Noida shall obtain necessary affiliation/ permission from the concerned affiliating University as per the prescribed schedule of the University/Admission Authority, etc. The Applicant Society/Trust/Institution shall send information about commencement of the above courses to AICTE. Incase the Institution could not commence the above mentioned courses for whatsoever reasons during the two years period from the date of issue of this letter, the approval becomes invalid and the applicant society/trust/have to make fresh application to AICTE for grant of a fresh approval.

The approval is further subject to fulfillment of following conditions:

- That the management shall provide adequate funds for development of land an 1-building and sforeproviding by the related infrastructural, instructional and other facilities as per Council's norms and standards laid down by the Council from time to time and for meeting recurring expenditure.
 - (a) That the admissions shall be made only after adequate infrastructure and all other facilities are provided as per norms and guidelines of the AICTE.
 - (b) That the admissions shall be made in accordance with the regulations notified by the Council from time to time.
 - (c) That the admissions to the courses shall be made only after the affiliating University has given permission to start the course.
 - (d) That the Institution shall not allow closure of the Institution or discontinuation of the course(s) or s art any new course (s) or after intake capacity of seats without the prior approval of the Council.
 - (e) That no excess admissions shall be made by the Institution over and above the approved intake ur der any circumstances.

That the tuition and other fees shall be charged as prescribed by the Competent Authority within the overall crieria prescribed by the Council from time to time. That the Director/Principal and the teching and other staff shall be selected according to procedures, The second second second second second qualifications and experience prescribed by the Council from time to time and pay scales are paid as per the norms That the institution shall furnish requisite returns and reports as desired by ALCIE in order to ensure proper mointenance of administrative and academic standards. That the technical institution shall publish an information booklet before commencement of the academic year giving details regarding the institution and courses/programmes being conducted and details of infrastructural facilities including faculty etc. in the form of mandatory disclosure. The information booklet may be made available to the stakeholders of the technical education on cost basis. The mandatory disclosure information shall be housed in the Institution Web-Site. The information shall be revised every year with updated information about all aspects of the institution. That it shall be mandatory for the rechnical institution to maintain a web-site providing the prescribed information. The website information must be continuously updated as and when changes take place. (c. That a compliance report in the prescribed format along with mandatory disclosure on fulfillment of the above conditions, shall be submitted each year by the Institution within the time limit prescribed by the Council from (c) That if Technical Institution fulls to disclose the information or suppress and/or misrepresent the information, appropriate action could be initiated including withdrawal of AICTE approval. 8. That all the laboratories, workshops etc. shall be equipped as per the syllabil of the concerned affiliating University and shall be in operational condition before making admissions. That a library shall be established with adequate number of titles, books, ournals (both Indian & Foreign) etc as To at a computer center with adequate number of terminals, Printers, legal software etc. shall be established as the second secon That a Joint FDR is required to be created for an amount and prescribed by the Council from time to time. T at AICTE may carry out random inspections round the year any time for verifying the status of the institutions That AICTE may also conduct inspections with or without notifying the dates to verify specific complaints of misrepresentation, violation of norms and standards, mal-practices etc. That the Institution by virtue of the approval given by Council shall not automatically become claimant to any g ant-in-aid from the Central or State Government. That the institution shall take appropriate measures for prevention of ragging in any form, in the light of directions o Supreme Court of India in Writ Petition No. (C) 656/1998. In case of failure to prevent the instances of ragging the institutions, the Council shall take appropriate action including withdrawal of approval. That the institution shall provide the following facilities for the physically challenged persons.

- That in the event of a student/candidate withdrawing before the starting of the course, the wait list d condidates should be given a mission against the vacant seat. The entire fee collected from the student, after a deputition of the processing of not more than Rs. 1000/- (Rupees One thousand only) shall be refunded and returned by the Institution/University to the student/candidate withdrawing from the programme. It would not be permissible for institutions and Universities to retain the School/Institution Leaving Certificate in original to force retention of admitted student. - 18. That the Management shall strictly follow further conditions as may be specified by the Council from time to time.
- 19. In the event of non-compliance by the R.V. Northland Instt. of Management, 18KM. On Ghaziabad Bulandshahar, G.T. Rd, Dadri, G.B. Nagar, with regard to guidelines, norms and conditions prescribed from time to time the Council shall be free to take measures for withdrawal of its approval or recognition, without consideration of envirelated issues and that all liabilities arising out of such withdrawal would solely be that of the R.V.
